*Dear Water Customer,*

December 16, 2021, the federal **Lead and Copper Rule Revisions** went into effect. The revised rule requires every federally defined community and non-transient, non-community water system to develop a lead service line inventory. The Village of Leicester needs your help to identify all unknown water service lines for the Village's water customers.

The information collected will be used to create a detailed inventory of all lines within our water system and will be made public following the survey.
